NATO MASTER CATALOGUE OF REFERENCES FOR LOGISTICS (NMCRL)




The NMCRL is by far the biggest and most detailed defence logistics database on a worldwide basis presenting unmatched functionality and vital information to Logisticians, Codifiers and the Industry. The new NMCRL version was introduced in January 2022 in parallel to the NATO Data Exchange Redesign (NDER) project and was entirely revitalized from a contents, functionalities and design perspective. The NMCRL allows for real time access to more than 18 million active NATO Stock Numbers (NSN) of NATO, Tier 2 and some Tier 1 member countries, as well as introduces innovative search capabilities, guaranteeing in this way ultimate customer satisfaction to worldwide users and the war fighter. Apart from the Web version of the product, which is updated

on a daily basis, the NMCRL Web Lite allows for a one-month free trial access period in order to enable potential users to harness the capabilities of the product. All in all, the NMCRL offers a contemporary tool to access significant business intelligence gathered from databases of NATO and sponsored member countries. AC/135 STRATEGIC PROJECTS

AC/135 is always exploiting state-of-the-art technologies in response to potential future requirements. As such, the Group is presently finalising the contents of two strategic studies: "Additive manufacturing and Codification impact"; "NSN versus part number within Enterprise-Resource-Planning (ERP) systems". Both studies will be released within 2022, where the Codification community eagerly awaits the conclusions and assess their impact on Codification.



THE AC/135 SPONSORSHIP PROGRAMME

NATO cooperates with a range of international organisations and countries in different structures. AC/135 supports this cooperation by offering non-NATO countries the opportunity to participate in the Sponsorship programme and become part of the NATO Codification System (NCS). As this programme was inaugurated in the 90s, it allowed AC/135 to progressively become NATO's largest Allied Committee. The Sponsorship programme promotes Codification, interoperability, underpins international teamwork and regional collaboration and allows AC/135 expertise to be leveraged by Sponsored nations. Today 34 nations are sponsored by AC/135 via this highly successful programme: 20 at Tier 2 and 14 at Tier 1.
